1 Your proposal for access to private property "M/s Suryavanshi Veshno Dhaba" at Km 104+040 (LHS) of NH-1(New NH-44) Vill- Malikpur, Tehsil Gharaunda & Distt- Karnal in the state of Haryana has provisionally been accepted by the Highway Administration, RO-MoRTH vide letter no RW/CH/PB/NH-1(44)/Km.104.040/NOC/1469/2018/3585-86 dated 12.11.2018, (Copy enclosed) subject to the following conditions:-

- (i) That you will construct the private property along with its access as per approved drawings at your own cost within 6 months of issue of provisional NOC. In case, the construction is not done in one year, the provisional approval shall deemed to be cancelled, unless renewed by the Highway Administration.
- (ii) That you shall arrange all the clearance required for constructing the proposed access as per approved drawing yourself. You shall also arrange for shifting of utilities of required at your own cost as per the direction of the concerned department.
- (iii) That you should take certificate from this office to the effect that the construction have been carried out by you is in accordance with the drawing approved by the Highway Administration at the time of final formal permission including issuance of signed license deed.
- (iv) That you shall execute necessary alteration including complete removal/shifting of the approach roads at your own cost if so required by Ministry, for the development of National Highway or in the interest of safety in this section.
- (v) That PD NHAI, Ambala shall have right to immediately close or dismantle the access in case the location becomes hazardous from traffic safety view point.
- (vi) That you shall not do or cause to be done in pursuance of the access permission any acts which may cause any damage to Highway.
- (vii) That you shall not do or cause to be done in pursuance of access permission any act by which safety and convenience of traffic on the Highway shall be disturbed.
- (viii) That you will ensure that proposed service road shall not be used for parking purpose and there is no overflow of vehicles on approach road.
- (ix) That height restriction of building structure shall be as local Govt. guidelines and the building line shall be as per the Punjab Land Improvement schemes Act, 1963 /Haryana Govt. Guidelines and IRC guidelines.
- (x) That you shall install all the requisite road signs as per IRC: 67 & provide road markings as per IRC: 35 & in accordance with the Ministry's guidelines dated 24.07.2013 to the satisfaction of this office.

(xi) That you shall furnish two sets of fresh license deeds (duly indicating chainages of both new & old NH no.) in two originals drawn on new stamp paper as per Ministry's standard norms and duly signed by authorized signatory along with his power of attorney & purpose of private property to be used at the time of issue of final permission.

(xii) That while utilizing permission you shall observe guideline relating to safety and connivance of traffic of the Highway, hygiene (in accordance with the requirement of Swachh Bharat Abhiyan). Prevention of nuisance and pollution on the Highway.

(xiii) That there shall be adequate drainage system on the access to the private property and inside its area so as to ensure that surface water doesn't flow over the highway of any water logging takes place.

(xiv) That you shall provide separator between service road and Main carriageway and construct service road at least 300mm below the main carriageway.

2. Development of National Highway is a continuous process and therefore the permission granted hereby for use of NH land doesn't restrict the development of NHs. Thus, the permission being granted hereby is provisional in nature. The provisional access permission granted hereby is without prejudice to the authority of Government to acquire applicant's land (plot of private property), if required for further development of National Highways.

3. MoRT&H vide letter dt 18.01.2018 has also directed for providing of toilet units in a uniform manner and a standard layout of toilet units has also been provided by MoRT&H which is enclosed herewith for compliance.

4. In this regard, it is also mentioned that additional increase in licence fee, if any, shall be submitted by you at the time of final access permission.

5. Notwithstanding to the above, the provisional NOC shall stand cancelled under the following circumstances:

- If any document/information furnished by you proves to be false or if the applicant it is found that you have willfully suppressed any information.
- Any breach of the condition imposed by the Highway Administration or the officer authorized by the Administration on his behalf.
- If at any later stage, any dispute arises in respect of the ownership of the land on which the private property is located or regarding the permission for change of land use.

This permission is further subject to the following terms and conditions:-

1. That the conditions of agreement executed by you with the Director, Town & Country Planning, Haryana, Chandigarh and the provisions of the Punjab Scheduled Roads and Controlled Areas Restriction of Unregulated Development Act, 1963 and Rules framed there under shall be complied with by you.
2. That you shall pay the External/Internal Development Works Charges as and when proposed site covered under urbanizable limit and demanded by the Department.
3. That you shall pay the additional amount of conversion charges for any variation in area at site in lump sum within 30 days as and when detected and demanded by the Director, Town & Country Planning, Haryana, Chandigarh.
4. That you shall give at least 75% employment to the domiciles of Haryana where the posts are not of technical nature and a quarterly statement indicating the category wise total employment and of those who belongs to Haryana shall be furnished to the G.M.D.I.C, Karnal.
5. That you shall get the building plans for the site approved from the Department before commencing the construction at site and will start construction within six months from issuance of change of land use permission.
6. That you shall deposit the requisite labour cess with the competent authority before approval of building plans.
7. That you shall obtain occupation certificate from the Department after completing the building within two years of issuance of this permission.
8. That you shall abide by the terms and conditions of NOC issued by NHAI.
9. That you shall not raise any construction on the land falling within 60 mtrs wide green belt proposed along National Highway and not object acquisition of the same in near future.
10. That you shall remove the unauthorized construction falling within 60 mtrs wide green belt within a period of 6 months from the date of approval of building plans and send its verification report from DTP, Karnal.
11. That you shall have no objection to acquire the land for road widening etc.
12. That this permission shall be valid for two years from the date of issue of this letter subject to fulfillment of the terms and conditions of the permission granted and agreement executed.
13. That this permission will not provide any immunity from any other Act/Rules/Regulations applicable to the land in question.


