



2. As per the provisions of clause 2.4 of the RfP, you will deposit the following amount within a period of fifteen (15) days from the date of issuance of LOA:

Upfront Premium of Rs. Rs.2,44,000/- (Rupee two lakhs forty four thousand only) payable in the shape of Bank Draft favouring Chief Executive Officer, JAKEDA.

- 3. As per the provisions of clause 2.2.1.2 and 2.13.1 of the RfP, you are required to fulfill the following formalities within a period of thirty (30) days from the date of issuance of LOA:
  - (i) Furnish a Performance Guarantee of Rs. 11,00,000 (Rupees eleven lakhs Only) per MW in favour of the Chief Executive Officer, JAKEDA as per format provided in Annexure 10 of the RfP;
  - (ii) Pay an amount of Rs.20,00,000/-(Rupees twenty lakhs only) on account of Pre-Development Cost as per schedule specified above; and
  - (iii) Execution of Implementation Agreement with JAKEDA in terms of RtQ/RFP document.
- 4. It is also clarified that you shall have no lien over the land of the project, water of the river, minerals if discovered etc. except to the extent, same is deemed essential for execution, completion, commissioning and operation of the project.
- 5. In case of any failure in fulfilling the required formalities within the allotted timelines, Jammu & Kashmir Energy Development Agency is at liberty to cancel this Letter of Award & invocation of Bid Bonds. Provisions of clause 2.12.2 of the RfP are reproduced hereunder for your reference:
  - "Subject to the provisions of Clause 2.2.2, the Bid Bond may be invoked by JAKEDA on account of any of the following:
  - Failure to execute the IA and other RfP Project Documents as per the provisions of Clause 2.2.1.2; or
  - Failure to furnish the Performance Guarantee as per Clause 2.2.1.2 and Clause 2.13; or
  - The Bid Bond shall also be invoked by the JAKEDA for submission of wrong information by the Bidder or making any misrepresentation in Bid as mentioned in Clause 2.7.1.3.

Intimation of the reasons of the invocation of the Bid Bond shall be given to the Selected Bidder within three (03) working days after such invocation."

6. It may be noted that by participating in the bidding process for selection of developers for development of Micro/Mini Hydel Projects in the state of Jammu & Kashmir, organized by JAKEDA, you have already provided your unconditional acceptance to the terms & conditions of the RFP document issued by JAKEDA. Further the date and time for signing of the Implementation Agreement (IA) will be indicated in due course of time.

## PREAMBLE:

2.0 MW Lashpathri-I Mini Hydel Project was awarded in favour of M/s Mass N-Ergy Pvt. Limited, Srinagar vide LOA No. ST/EDA/74/2015/P-II/2610-22 dated 04.08.2017.

The IPP Mass N-Ergy Pvt. Limited submitted the DPR for an installed capacity of 8.5 MW given the availability of power potential at the site and requested JAKEDA for accord of Techno-Economic Clearance (TEC). The TEC Committee constituted vide G.O. No 19-A-ST of 2013 dated 22.10.2013 scrutinized and deliberated over the DPR and decided to grant the necessary TEC for development of the project.

# TECHNO ECONOMIC CLEARANCE

Therefore, Techno Economic Clearance is hereby accorded for development of 8.5MW Lashpathri-I Small Hydel Project.
