Sr. No.	Query	Compliance
1	Examination of KML file of CA land revealed that KML file is submitted only for 102 ha., KML file of remaining area is not submitted along with the proposal. Further, discrepancy is observed in CA details submitted along with the proposal and KML file uploaded on Parivesh portal. In proposal it is mentioned that CA will be carried over 10 ha in Compt no. 292, whereas, KML file of Compt. no. 592 has been uploaded twice. Correct KML file of all patches needs to be submitted.	No comments from this office.
2	It has been mentioned that proposed project is 3.465 Km from Chaprala Wildlife Sanctuary and 3.5 Km from Pranhita Wildlife Sanctuary. Whereas, DCF, Allapalli has mentioned in his certificate that Chaprala Wildlife Sanctuary is at distance of 0.00 Km and Pranhita Wildlife Sanctuary is at a distance of 3.500 Km. Clarification in the Statement made by DCF, Allapalli needs to be submitted.	Previously the road was proposed from the end of Chaprala Wildlife Sanctuary. Later state Government decided to remove the length of road in Eco Sensitive Zone (3.465 km). Hence the discrepancy.
3	Proposed project is 3.465 Km from Chaprala Wildlife Sanctuary and 3.5 Km from Pranhita Wildlife Sanctuary. However, Eco-sensitive Zone of Chaprala Wildlife Sanctuary varies from zero to 5.0 kilometers and that of Pranhita Wildlife Sanctuary varies from zero to 6.3 Km. 
