In the reference 1<sup>st</sup> cited, the Conservator of Forests , Visakhapatnam has submitted the DGPS surveyed maps and raw data for verification and authentication of forest area over an extent of 2.71 ha in compartment no. 452, 453 & 454 of Moduga RF, Moduga beat, Ananthagiri Range, Visakhapatnam Division and compartment no. 38 & 387 of Thaduru RF, Muthumuru beat, Saluru Range, Vizianagaram division for **formation of road Vetaganivalasa to Tangalam road Mutukudu via Boddapadu**.

The DGPS surveyed maps and raw data received were got verified and authenticated by this office and the area arrived for the proposed forest land is in compartment no.452, 453 & 454 of Moduga RF, Moduga beat, Ananthagiri Range, Visakhapatnam division and compartment no.381 & 387 of Thaduru RF, Muthumuru beat, Saluru Range, Vizianagaram division, **is 2.75 ha**. (Bit-1: 1.03 ha. Bit-1: 1.44 ha. Bit-3: 0.28 ha).

In orders to supply the maps, the User Agency is required to pay User Charges of **₹9,000/-** (Bit-1: 1.03 ha. Bit-1: 1.44 ha. Bit-3: 0.28 ha) towards verification and authentication of maps as per the circular instructions issued in PCCF & HoFF , A.P., Guntur in Rc. no. 24529/2006/M&E-1 (IT-I), dated: 18.01.2016.

The authenticated maps is communicated herewith. The Divisional Forest Officer, Vizianagaram division is requested to release the authenticated map to the User Agency duly signed on the map after verifying with Gazettee Notification of RF block and supply to the User Agency by collecting an amount of **₹9,000/-** by way of Demand Draft in favour of Forest Utilization Officer, Andhra Pradesh, Guntur towards User Charges and submit the Demand Draft to

the Forest Utilization Officer, A.P., O/o the Prl. Chief Conservator of Forests & Head of Forest Force, A.P., Guntur under intimation to this office.
