A proposal have been received in this office from the Executive Engineer, HPPWD Division- Chowari for diversion of 1.8086 hectare of Forest Land (under Section-2 of Forest Conservation Act-1980) for non forestry purpose. The subject envisages the use of forest land for C/o - Link Road from gahar da ghatu to Village Lanoh (0/0 to 3/510 km). The site inspection of the land involved in the proposal has been done by me on dated 06-10-2025
2. On inspection of the site, it is found that the land required by the user agency is a forest area measuring 1.8086 Hectare.
3. The requirement of forest land as proposed by the user agency in Col-2 of Part-I is unavoidable and is barest minimum required for the construction of road. **(Yes)**
