2	As per the DSS analysis, the proposed diversion area calculated as 0.67 ha instead of 2.413 ha. In this regard, the User Agency shall upload a correct KML file.	Correct KML calculated as 2.413 ha, and uploaded at Part-I.
3	As per the DSS analysis of CA area, the area is calculated as 4.41ha instead of 4.426 ha. Re-check and correct the KML file.	Correct KML of CA calculated as 4.426 ha, and uploaded at Part-I.
4	The user agency shall submit the full KML file of the proposed road alignment including forest area and non-forest area.	Full KML file of the proposed road alignment including forest area and non-forest area has uploaded at Part-I.
5	It is also observed that the muck dumping site are proposed in forest land only, in this regard a detailed report of DFO for possibility of muck dumping sites in non-forest area shall be submitted.	Muck Dumping site is proposed in Civil Soyam land in Km 1 & 2, where no trees are being affected. In Km 3 Van Panchayat land is proposed in bared land. Due to non availability of non-forest is the above land is proposed for muck dumping with a length of 75 to 90 mtrs.
6	The CA scheme is submitted as per the old rates. A revised CA scheme on current wage rates as per actual field position is required.	Action Taken from your end please.
7	Prior taking the CA land, the State Forest Department shall ensure that the CA area has been properly fenced by the user agency. The user agency shall also submit an undertaking for the same.	Undertaking for the same is enclosed herewith in this letter.
8	The User Agency shall submit the Geologist report.	Geologist report duly authenticated by AE is enclosed.
