The muck produced from all the components would be self utilized with due consideration of its distance from the component, suitability of the area and Topography point of view.

**Rehabilitation Proposal**

Since there is no displacement of any population due to the construction of the Parking Place, there will be no rehabilitation problem.

**Afforestation**

Compensatory afforestation shall be carried out by the forest department for which compensation shall be paid by the user agency. The area involved for diversion is 0.0750 hac. which is less than 1 ha so Compensatory Afforestation for plantation of 150 tall plants shall be carried on by the forest department.

**Retaining walls**

RR Masonry / GI Wire crate filled with boulders/ stones reclaimed from excavation of various project components shall be used for construction of retaining walls for retaining the surplus excavated earth / muck as per standards adopted with due consideration to site condition.

**Use of muck/debris**

The entire muck/debris obtained from the project components shall be used for manufacture of aggregates for construction work, filling in wire creates, retaining walls, stone masonry works, breast wall, etc.

A retaining wall of 50 m length is required to be constructed and muck generated i.e. 232 m<sup>3</sup> shall be utilized for the backfilling of this retaining wall which requires about 240 m<sup>3</sup> muck. So the muck generated i.e. 232 m<sup>3</sup> shall be utilized locally.



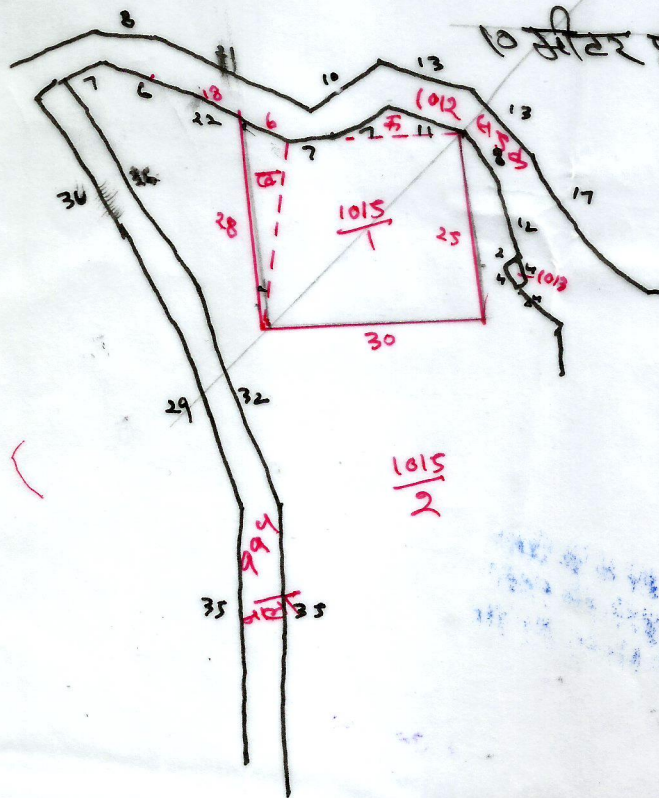
