With reference to above mentioned Subject, we would like to inform you that, We have submitted the Forest Diversion Proposal for 3.85 hectare Forest Land for Construction of 11 KV HT line from 33/11 KV Bekariya Substation to Wolkem Industries Ltd. Kheratarla Mine Situated near Uparla and Nichala Khera, Tehsil – Bali & Kotra , District – Pali & Udaipur, Rajasthan vide Proposal No. FP/RJ/TRANS/142368/2021 on dated 07th June. 2021.

Proposal was recommended by your good office on dated 16th December, 2021 and Chief Conservator of Forest, Circle Udaipur site visit was done on dated 24th January, 2021.

As per directions and above mentioned EDS letter of Chief Conservator of Forest and Dy. Conservator of Forest, Udaipur-North again alternative has been examined to avoid some dense plantation in the forest land proposed for diversion therefore as per the revised Proposed route of 11 KV transmission line required forest land will be 3.3896 ha. Instead of 3.85 ha therefore we have submitted the revised Proposal in 5 Sets hard copies.

In this regards we have also submitted the request letter to Add. Principal Chief Conservator of Forest, Cum Nodal Officer, FCA Aranya Bhawan, Jaipur (Raj.) to change the area but concern officials conveyed the message that area will be changed after recommendation of concern DCF and CCF.
