Subject:- Issue of No objection certificate for development of retail outlet proposed on Bapoli to Sanoli road (SH-16), near Km. Stone no. 18, at village Jalalpur-I Distt. Panipat.

Reference:- Your letter No. 443-52 dated 03.03.2015.


NOC has been granted as the same has been approved in the minutes of meeting held under the chairmanship of Sh. Ramesh Kumar, Superintending Engineer, Karnal Circle, PWD B&R Br., Karnal on 01.04.2015 for the proposed retail outlet subject noted above is setup in the parameter as per latest norms fixed by the Ministry, Road and Transport Highways as well as the PWD B&R authority and as per drawings received in this office vide letter under reference and also as per subject to the following:-

1. There should not be any encroachment on PWD land at the time of construction/ installation of Retail Outlet.
2. The level of the floor of the outlet should be kept lower than the metalled level of the existing road.
3. No building has been constructed hence safety of the building can not be ascertained.
4. There will be no violation of the guidelines for setting up motor fuel filling and motor fuel filling cum service station as contained in IRC-12-2009.
5. Adequate arrangement be made by the owner of the outlet to ensure that there should not be any flow of water on the road from outlet side i.e. by constg. drain.
6. The land width shall remain same as per revenue record / PWD authority.
7. The note kept in the drawing may please be followed by the owner of the outlet.

8. The department may also be informed by the agency / Essar Oil Company at the time of start of construction.
9. Agency will have complete the construction / assess as per latest MORTH / IRC guideline within one year after issue the NOC and completion certificate to this effect shall be issued by PWD authority. Failure to comply with this shall attract cancellation of NOC.

Necessary lease money for the 15 years i.e. Rs. 40000/- has been deposited vide Demand Draft No. "327498" dated 13.04.2015 of Karnataka Bank Ltd., G.T.Road, Panipat.
