Undertaking has been provided that the User Agency either itself or through the State Forest Department shall undertake fencing, protection and afforestation of the safety zone area i.e. 7.5-meter strip shall be kept within the mining lease at the project cost. Area of safety zone of a mining lease shall be a part of the total area of the mining lease.

7.5-meter-wide peripheral safety zone within the Mining lease area will be properly demarcated with boundary pillars with DGPS coordinates inscribed on them and to be maintained as effective green belt. CA and NPV will be regulated as per the guidelines related to CA & NPV.

Cost of raising and maintenance of compensatory afforestation and/or penal compensatory afforestation as well as cost for protection and regeneration of Safety Zone, etc. as per the scheme prepared by the State Government.

The project area of Pachwara South Coal Mine Project is 714.8553 Ha. Out of which forest area is 455.1108 Ha and Non forest area is 259.7445 Ha. (as per Revised land schedule by DFO, Dumka.).

The forest area within the safety zone (minimum7.5 meter along the periphery of the lease and other consideration as per the approved Mine Plan) of the block is comes to around 8.5003 Ha. and safety zone within the non-forest area of the block comes to around 2.3397 Ha. Safety zone is considered as per the approved Mine Plan of Pachwara South Coal Mine Project by Ministry of Coal, Govt. of India and "Handbook of Forest (Conservation) Act,1980 and Forest Conservation Rules, 2003 (Guidelines & Clarifications) 2019" published by Ministry of Environment Forest and Climate Change, Govt. of India.
