

UNDERTAKING

The project does not involve any tree felling. However, we undertake to bear the extraction charges if any tree felling is required.

UNDERTAKING FOR PAYMENT OF NPV

No NPV is required for linear projects like Optical Fiber Cable. However, we, the User

Agency hereby undertake to pay the cost of Net Present Value of Forest land if required.

UNDERTAKING

The cable line shall be laid at 1 Mt below the ground level and the forest land shall be restored to its original state after laying the same. The maximum size of the trench shall not exceed 2.00 mt. depth and 1.00 mt. width.

UNDERTAKING

The layout plan of the proposal shall not be changed without the prior approval of the

Central Government.



UNDERTAKING

The minimal disturbance shall be ensured by creating labour camps outside the forest area as far as possible and it will be our responsibility to ensure that the labourers and staff engaged in execution of work do not destroy the nearby forest flora and fauna.

UNDERTAKING

The Project does not involve felling of trees as OFC is laid within the Road boundary along the Road.



UNDERTAKING

The work shall be taken up during day time only and no work shall be carried out during night time.

UNDERTAKING

The total forest area required for the project shall not exceed 0.2789 ha in Tadvai Forest Division and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal.



UNDERTAKING

We ensure the compliance to provisions of the all Acts, Rules, Regulations and guidelines, for the time being in force, as applicable to the Project.

CERTIFICATE FOR BARE MINIMUM
