UNDERTAKING FOR PAYMENT OF NPV

No NPV is required for linear projects like Optical Fiber Cable. However, we, the User Agency hereby undertake to pay the cost of Net Present Value of Forest land if required.

UNDERTAKING

The cable line shall be laid at 1 Mt below the ground level and the forest land shall be restored to its original state after laying the same. The maximum size of the trench shall not exceed 2.00 mt. depth and 1.00 mt. width.

UNDERTAKING

The layout plan of the proposal shall not be changed without the prior approval of the

The minimal disturbance shall be ensured by creating labour camps outside the forest area as far as possible and it will be our responsibility to ensure that the labourers and staff engaged in execution of work do not destroy the nearby forest flora and fauna.

CERTIFICATE FOR BARE MINIMUM

It is only Right of Way (RoW) permission required for laying Optical Fiber Cable (OFC) all along the road at the edge and within the road boundary in the existing Right of Way (RoW). No diversion or de-notification of forest land is required.

This is to certify that the forest land through which the OFC is being laid is barest minimum area for the purpose and there will be no further requirement of additional area. We the User Agency also undertake not to shift to any area other than the area mentioned in the proposal. We also certify that no suitable private or Government non forest land is available for laying the OFC in the proposed route.
