- 1. To sign and execute the sale deeds pertaining to the purchase of land, to complete the registration, Filling application for N.A and mutation process, and to receive the relevant title documents pertaining to Project in the state of Karnataka.
- 2. To apply approval u/s 164 of Electricity Act including Gazette notification, application to CEA, Ministry of Power and other relevant authority.
- 3. To prepare, sign application/ agreement (including Connection Agreement), submit application or collect data from Power Grid Corporation of India Limited and its subsidiaries in relation to any of the matters relating to the project of the Company.
- 4. To prepare, Sign & submit application for all the statutory clearance (PTCC, Railway Crossing Clearance, Power Line Crossing Clearance, Forest Clearance, National Highway, State Highway, Civil Aviation, Defence, Central Water Regulatory Commission, Irrigation Deptt. etc) to the concerned authorities in relation to any of the matters relating to the project of the Company.
- 5. Apply to local authorities like Gram Panchayats, District Collector, District Magistrate and Zilla Parishads etc for obtaining all kinds of permissions, approvals, consents including but not limited to the "Right of Way" or No Objection Certificates, as may be required.

To verify, sign, affirm and present pleadings, petitions, affidavits, statements, vakalatnama, written submissions etc. and to tender evidence both oral and documentary in connection with any such legal proceedings and or legal matter and to do all acts, deeds, matters and things as may be necessary in connection therewith and/or incidental thereto including engagement and appointment of solicitor/(s), advocate(s) or counsel for the above purpose.
