This is with reference to the subject cited above. In this connection it is submitted that we have attended the shortcomings noticed in above proposal. The observations have been corrected as per your requirement. The Point wise reply to the observations is as under:-

1	In reply to query no. 9, regarding NOC from the Department of IPH/Jal Sakti Vibhag, HPPWD, HPSEB Ltd., Fishery Deptt., MC Shimla/TCP Deptt. and HPSPCB for construction/establishment of the proposed project, it has been submitted that NoCs have been uploaded in Part-I. However, these NoCs are not found uploaded.	The required NOC's from all departments has been uploaded online against Additional Information Detail and is enclosed herewith in quadruplicate. Undertaking for the NOC from Fisheries Department has been enclosed and uploaded online in the Parivesh portal.
2	In reply to query no. 10, regarding NoC issued by the HPPWD for direct access/approach from MDR, it has been submitted that NoC has been uploaded in Part-1. However, required NoC is not found uploaded.	The required NOC from HPPWD has been uploaded online against Additional Information Detail and is enclosed herewith in quadruplicate.
3	In reply to query no. 12. regarding aerial distance of project site from the boundary of Chail WLS and its notified ESZ along with comments of CWLW, if required, it has been submitted that same will be submitted before Stage-II (final) approval. However, same is required to be submitted before Stage 1.	This observation pertains to CCF Office

4	A component "Open Area" having area 0.0725 hectare is also proposed in the project State Government needs to properly justify the requirement of this component, else this component need to be removed from the diversion area because diversion of forest land for non-forestry purpose shall be for barest minimum purpose.	After execution of project, actual open land may be vary according to construction of components.
