ORDER:-

In accordance with the administrative clearance for 12 road works for RCPLWE Batch-1 proposals for the year 2020-21 communicated by the Ministry of Rural Development, Government of India in the letter 1st read above, the Engineer-In-Chief, Panchayat Raj, PMGSY, A.P. Vijayawada has submitted a list of 12 road works measuring a length of 68.85 km for an estimate cost of Rs.5311.90 lakhs cleared by the Government India for according administrative sanction from the Government. The abstract of cleared proposals of Road works are as follows:-

In accordance with the administrative clearance communicated by the Ministry of Rural Development, Government of India in the letter 1st read above and after examination of the proposals received from the Engineer-In-Chief, Panchayat Raj, Government hereby accord administrative sanction for 12 road works listed in the annexure appended to this G.O. measuring a length in 68.85 km for an estimate cost of Rs.53.119 Crores (Rupees Fifty Three Crore eleven Lakh and ninety thousand only) with MoRD Share: Rs.31.8714 Crores (Rupees Thirty One Crore Eighty seven lakh and fourteen thousand only) and State Share Rs.21.2476 Crores (Twenty One Crore twenty four lakhs and seventy six thousands only) for both construction and maintenance (maintenance shall form an integral part of Contract Agreement as per RCPLWE guidelines). The list of works accorded clearance and its details communicated by the Ministry of Rural Development, Government of India vide letter 1st read above is final for all purposes.

The above instructions shall be followed scrupulously. If such works as sanctioned in this GO are already grounded etc., they shall be deemed to have been cancelled automatically and the same shall be informed to Government immediately for taking further necessary action.

4. The Engineer-In-Chief, Panchayat Raj, Andhra Pradesh, Vijayawada shall take necessary action in the matter and submit the Utilization Certificates to Government soon after completion of the work in the stipulated time.
