POWERGRID, country's Central Transmission Utility (CTU) and a Navaratna Company under Ministry of Power, is engaged in power transmission business,owns and operates about 1,38,000 circuitkMof transmission lines across the length and breadth of the countrywheeling the country's power.We areentrusted with the task of establishing 800kV HVDC Tranmission line from Raigarh (Chattishgarh) to Pugalur (TN) vide Govt of India approval vide No 52/11(PGCIL)/2015-PSPA-11/134 dated 18.02.16 (copy enclosed). This project is envisaged to enhance the power scenario of the southern states and further strengthen the National Grid.
