ALTERNATE SITES CONSIDERED TO MINIMISE THE USE OF FOREST LAND FOR CONSTRUCTION OF SEPTAGE TREATMENT PLANT AT SAKOH IN TEHSIL DHARAMSHALA, DISTRICT KANGRA

ALTERNATIVE-I

The proposed project is situated in Mohal Panjehar, Tehsil Dharamshala, District Kangra. The area proposed for diversion is 0.4047 hectare of forest land. The area proposed is situated far away from the residential area and 13 number of trees are coming in the alignment of the proposed plant.

Feature considered:

- Alignment of the proposed project is barren land and suitable for the construction of Septage Treatment Plant.
- Forest land involved to the tune of 0.4047 Hectares.
- Less disturbance to the stable slope & green cover.

ALTERNATIVE- II

The proposed project is situated in Mohal Panjehar, Tehsil Dharamshala, District Kangra. The area proposed for diversion is 0.6650 hectare of forest land. The area proposed is situated far away from the residential area and 26 number of trees are coming in the alignment of the proposed area.

Feature considered:

- Alignment of the proposed area is vulnerable to land slide.
- Forest land involved to the tune of 0.6650 Hectares.
- Felling of 26 number of trees
- More disturbance to the stable slope & green cover.

ALTERNATIVE- III

The proposed project is situated in Mohal Panjehar, Tehsil Dharamshala, District Kangra. The area proposed for diversion is 0.44 hectare of forest land. The area proposed is situated far away from the residential area and 32 number of trees are coming in the alignment of the proposed area.

Feature considered:

- The area proposed is situated on the ridge that requires cutting of slopes, thus adding to the cost of the Project.
- The forest land involved to the tune of 0.44 hectare.
- The area proposed is not suitable for the construction of Septage Treatment Plant.
- Felling of 32 number of trees is involved.

Keeping in view of the above facts, the alternative- I, which is suitable and environmental friendly, has been adopted for the construction of Septage Treatment Plant.






