Dear Sir,

GAIL (India) Ltd. has planned for connecting 4" underground pipeline to supply Natural Gas from GAIL SV-11 Chaubari Bareilly to HPCL CGS Bareilly for an approximate length 950 m. The Start point (28.296956° N & 79.386331° E) and End point (28.293739° N & 79.382305° E) co-ordinates of the connectivity are mentioned above. As a part of the project, clean natural gas will be made available to various domestic, commercial and industrial customers across the districts. This will directly result in reducing pollution due to use of fossil fuel, improving the environment and will also greatly benefit the people of the region by being able to easily access clean and efficient fuel for their needs.

The proposed project passes through 0.0316 Ha. of forest land (linear diversion) in Bareilly Forest Division in Bareilly district. Forest Area statement for the same is enclosed as Annexure-I. The forest diversion proposal for the same is applied online vide online proposal no. FP/UP/Pipeline/153250/2022 enclosed.

As per Forest Conservation Act, 2003 the District Collector is required to complete the process of recognition and vesting of forest rights in accordance with the provisions of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (2 of 2007) for the entire forest land indicated in the proposal. In Compliance of the above the District Collector shall provide Form-II Certificate as linear project enclosed as Annexure-II.
