## Brief History of the Project

1. **M/s.Sathagiri Educational Trust** is a registered Trust under “**Tamil Nadu Societies Registration Act 27 of 1975**” in the year 1994. We have proposed for the widening of the existing approved approach Road leading to Sri Sairam Engineering College and other Educational Institutions in S.No.368 of **Naduveerapattu** village in Nallur **RF** area, Sriperumpudur Forest Range, Chengalpattu Forest Division, Sriperumpandur Taluk, Kancheepuram District to the needs of the students, staff transport and other developmental activities as per the specification imposed by the CMDA in the II master plan area.

2. We are running the following Institutions at Sai Leo Nagar in Poonthandalam Village in the Sri Sairam Engineering College campus at Poonthandalam village, west Tamabaram, Chennai – 44.

2. Sri Sai Ram Institute of Technology
3. Sri sai Ram Institute of Management Studies
4. Sri Sai Ram Siddha Medical College
5. Sri Sai Ram Ayurveda Medical College
6. Sri Sai Ram Homoeopathy Medical College
7. Sri Sai Ram Advanced Centre for Research
8. Sri Sai Ram Polytechnic College
9. Sai Ram Matriculation Hr.Sec.School

3. Our above captioned Educational Trust and Management having **rich** and **vast** experience in running the Educational Institution and to conduct various professional and academic courses in an effective and proper manner for the **past 3 decades**. We have **Record** of good results in all our Educational Institutions. We are very proud of it to provide such quality of education in the educational field not only in Chennai city / all over state of Tamil Nadu.

4. We are running the above Engineering, ISM Medical and other Educational Institutions in this **Sriperumpudur Assembly and LOK Sabha constituency** mainly to cater the needs of the quality education to the **SC/ BC/MBC** and **other down trodden people** living in this rural area of **Sriperumbudur Taluk** and **Tambaram Taluk** of Kancheepuram District.

5. Presently, we got existing approved approach Road through Nallur **RF** Area from the main road of **Tambaram - Naduveerapattu** to reach our Sri Sairam Engineering college and other Educational Institutions at our Sai Leo Nagar College campus. The land for existing approach road was obtained from the GOI in **Nallur RF** (0.84 Hec) under transfer and mutate our own Patta land of 1.68 Hec. double the extent of compensatory land in survey **No. 218 of Perunthandalam Village**, Tirupporur Taluk of Kancheepuram District.

The very same existing approach Road was already approved by the GOI, Ministry of E&F and the Govt. of Tamil Nadu in their GO MS No.83 E&F (FRIO) Dept. dt 21.08.2006 .

In this connection, we wish to state that the Poonthandalam village comes under the Institutional zone area approved by the II<sup>nd</sup> Master Plan of the CMDA. The CMDA now insisting us that the approach road to the Educational Institutions must be in the width of Minimum 60'. Less than this limit, the CMDA did not accept and approve our **building plans** and other **structural** and further developmental activities of our Educational Institutions.

Hence we are sending this diversion of Forest land proposal under **Forest (Conservation) Act 1980** with as usual condition of the state and central Govts as we have already obtained approvals from the Govts for the formation of existing approach Road to our Sri Sairam Engineering College (References are enclosed along with this proposed)

In the proposed Forest land, there are some trees which are unused / not valuable here and there are some unwanted bushes scattered. There are no well grown trees in the proposed site. There are no rare and endangered species in the proposed site and if our proposed widening of Road is formed, it will be great safeguard to **Nallur RF** and no one can be entered into the **RF** area illegally.

In this regard, we also state the following to the kind notice of the State Government / State Forest Department / Government of India, E&F Department:-

- (1) **We are ready** to obey the conditions imposed by Government of Tamil Nadu, Environment & Forest Department / Government of India, Ministry of Environment & Forests, Bangalore Region / New Delhi.
- (2) **We are ready** to transfer and mutate our own patta land over double extent to the Forest Dept. for Compensatory Afforestation purpose as per the G.O. Ms.No.706, E&F (FR-XI) Dt.12.12.1996.
- (3) **We are also ready** to remit the necessary compensatory afforestation charges as per the guidelines of Government of India to Ad-hoc CAMPA in account number. CA. 1579 of Corporation Bank, Block-II, CGO Complex, Phase-I, Lodhi Road, New Delhi – 110 003 and latest instructions by the Government of India, MOEF, New Delhi – 110 003.
- (4) **We are ready** to pay the Net Present Value (NPV) amount as per and 09.05.2008 in I.A, No.826 in 566 with related IA's writ petition (Civil) No.202/1995. (or)

**We are ready** to pay the higher NPV amount fixed in the above Hon'ble Supreme Court of India orders.

- (5) We assure that the Trust will not deviate the Forest (Conservation) Act 1980 rules and guidelines while implementing the project work.

Taking into consideration of our request for the allotment of **0.56 Hec'** (1.382 Acres) of Forest land for the above the widening of the existing approved approach Road leading to our Sri Sairam Engineering College **purpose**, as per the guidelines issued by the Government of India in their **Lr.No: F.No: 5-3 / 2007 / FC dt: 05.02.2009**. Hence **M/s.Sapthagiri Educational Trust** is sending necessary proposal to Government under Forest (Conservation) Act 1980 for the diversion of above Forest Land for further consideration. Therefore, we are sending this proposal to Government for diversion of said Forest Land under Forest (Conservation) Act 1980 to our **M/s.Sapthagiri Educational Trust, Chennai-17** for widening of the existing approved approach Road leading to **Sri Sairam Engineering College and other Educational Institutions**.

We therefore request that our proposal may kindly be considered favorably and necessary action / orders may be passed for obtaining the concurrence of the Government of Tamil Nadu, in Environment and Forest Department for the Diversion of **0.56 Hec** forest land in **Nallur RF** for the widening of the existing approved access road to our Educational Institutions at **Sai Leo Nagar, Poonthandalam** Village in Kancheepuram District.
