

 It is to submit that the Deccan Cements Limited (DCL) submitted online application.
 [Under Forest (Conservation) Act, 1980] to the Forest Department for diversion at 8.02 Ha. of Forest land to railway track and associated activities in Comp. No 25 Saidulnama RF, Janpahad Section, Huzurnagar Range, Suryapet District, Telangana State.
- 2. In this connection, it is to submit that the Government of India has enacted the Scheduled Tribes and other traditional Forest Dwellers (Recognition of Forest Right Act, 2006 which came into force on 13.12.2007 and the Rules made there under came into force w.e.f. 01.01.2008. Subsequently, State Government issued operation of guidelines vide GO 1st cited wherein various procedures to be followed have been explained. State Government has also issued another GO vide 2nd cited for certain modified guidelines. Copies of two GOs are enclosed herewith for kind perusal.
- 3. For clearance of all the Forest land diversion applications, the Ministry of Environment Forests & Climate Change (MoEF&CC), Government of India is asking to submit Certificate from the Chairman (Collector & District Magistrate) of the District Leve Committee appointed under Recognition of Forest Rights Acts, 2006 after thorough enquiry and due process as defined in the Act. As such, this requirement is mandatory whether there any encroachments are not in the Forest land proposed for diversion. A part Topo plan showing the proposed Eorest land proposed herewith.
