**Subject:** Proposal for granting of permission under section 2 (iii) FC Act, 1980 towards re-grant of Kharsang Petroleum Mining Lease (PML) covering 9.94 Sq.Km. (originally proposed 11.00 Sq.Km.) in favour of M/s. GeoEnpro Petroleum Limited falling in Changlang District of Arunachal Pradesh.

This is with reference to the Ministry of Environment, Forest and Climate Change (MoEF & CC) letter dated September 27, 2017 conveying approval of the Central Government to State Government of Arunachal Pradesh under Section 2(iii) of the Forest (Conservation) Act, 1980 for assignment of lease, concerning an area of 9.94 Sq. Km. (originally proposed 11.00 Sq. Km.), subject to certain conditions.

We have made the following payments as per conditions of MoEF & CC letter -

**Condition No. (ii) –** (Refer State Forest Department letter dated October 13, 2017)

Net present value (NPV) @ 2% of entire forest land allowed to be assigned on mining lease amounting to Rs. 1,69,98,640/- (Payment details enclosed as Annexure-I).

**Condition No. (iii), (iv) and (vi) of MoEF & CC letter –** (Refer State Forest Department letter dated September 06, 2018)

- **Condition No. (iii) –** Net present value (NPV) at the rate of 20 % for the area under violation, for each year since 1995 the violation of Forest (Conservation) Act 1980 has commenced, amounting to Rs. 10,21,09,480/-
- **Condition No. (iv) –** Penal CA on degraded forest land equivalent to the land utilised in violation of the provision of Forest (Conservation) Act, 1980; amounting to Rs. 2,36,19,700/-
- **Condition No. (vi) –** Lease transfer charges as per the procedure laid down in Ministry's guidelines related to lease transfer charges, amounting to Rs. 5,00,000/-

The payment details for the above charges against condition no (iii), (iv) & (vi), totalling to Rs. 12,62,29,180/- is enclosed as Annexure-II.

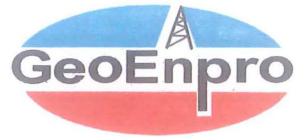

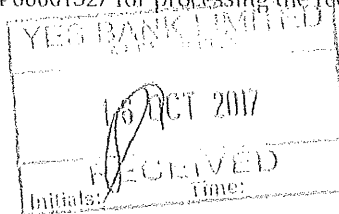
