In this context, it is submitted that as per copy of DPR for wildlife conservation plan received from HPPWD Solan and the same has been enclosed/ uploaded in the eparivesh portal. It is to be informed that the road will serve 11 Nos. of villages, which will improve the economy as well as life quality of these villages. The horticulture and agriculture produce are grown in the area and people face lot of problems in marketing the crops for want of road. The other services like health, education and other development activities will be improved with the construction of this road.


- The provisions of additional/causeways/slab culverts to provide free corridor to the wild animal have been proposed throughout the stretch of road namely "Kiari to Khinna Kd. 0/000 to 7/820" at RD's 3/465, 4/575, 5/200, 5/950, 6/465, 7/270,7/540. Road at these locations passes adjoining to the forest area and the causeways/ slab culverts have been designed in a way to cater smooth movement of animals without any hindrance. It is hereby undertaken that any change in the location or number of causeway/ slab culverts as desired by the Forest Department shall be made in the DPR at all the stages of the execution of work.
- The provision for construction of water bodies to store the rain water for wild animals the causeway/Slab culvert has been made in the DPR. These water bodies shall also be constructed in way to help restoring the ground water level of the area. In additional to this, PWD shall also construct two pounds for storage of water in the area and to rejuvenate the ground water level for the area.
- The PWD undertakes to plant fruit bearing trees all along the road at the distance of 3 meters.


