With reference to letter 1<sup>st</sup> & 2<sup>nd</sup> cited above, it is to inform that Regional Office, Chennai vide reference 4<sup>th</sup> cited has approved the for Laying of Underground 24" dia Steel Gas Pipeline along with 40mm dia OFC duct along the road from km.60/100 to km.94/460 (RHS) on Jittandahalli to Dharmapuri section of NH-844 (Package -3) by M/s. Gail (India) Ltd., and subsequent to submission of track rent charges / License Fee for Rs.1,09,00,315/- and Bank Guarantee No.0505323BG0001419 dated 27.03.2023 for Rs.86,41,000/- the approval of the Competent Authority is hereby communicated subject to the following conditions:

 The laying of Underground Gas Pipeline shall be strictly as per the Ministry's letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and as per the details / drawings indicated in the proposal. No change in the alignment of water pipe than approved herein will be entertained. Any deviation may result in cancelling of the permission/ approval.

- 2. As per Ministry's letter dated 22.11.2016 M/s. Gail (India) Ltd shall ensure that the laying of Underground Gas Pipeline is not laid over the existing Culverts & Bridges except through the utility ducts where such provision exists. In case of absence of such provisions, M/s. Gail (India) Ltd shall make its own arrangements for crossing the cross-drainage Structure, rivers etc., below the belt.
- 3. All the existing utilities are to be checked and verified by M/s. Gail (India) Ltd before commencement of the work and ensure that no damage is caused to the existing utilities. If any damages are caused to the existing utilities by M/s. Gail (India) Ltd has to bear the cost of rectification works.
- M/s. Gail (India) Ltd should adopt Trenchless technology wherever Underground Gas Pipeline crosses the cross roads/junction locations and wherever the berm width is less.
- 5. No digging of the carriageway will be allowed and working pits, if any, shall be made outside the ROW.
- M/s. Gail (India) Ltd shall ensure that, avenue plantation, rainwater harvesting system and boundary stones are not disturbed. Damages any, shall be got rectified under Risk and Cost of M/s. Gail (India) Ltd.
- M/s. Gail (India) Ltd shall follow the latest guidelines issued by MORT&H while executing the work.
- Free flow of traffic on NH-844 should be maintained at any point of time by M/s. Gail (India) Ltd while carrying out the work of laying of Underground Gas Pipeline
- The proposed laying of the Underground Gas Pipeline shall be laid in such a manner that it causes least interference to the traffic movement and also traffic safety.
- 10. M/s. Gail (India) Ltd will be responsible for any hazard during the laying of Underground Gas Pipeline.
- 11. M/s. Gail (India) Ltd shall shift the utility services within 90 days (or as specified by the respective authority) from the date of issue of the notice by the concerned Authority to shift/relocate the utility services, in case it is so required for the purpose of improvement / widening of the road/route/highway or construction of flyover/bridge and restore the road/land to its original condition at Risk and Cost of M/s. Gail (India) Ltd.

- 12. The interference with any other service line exist in the alignment of the proposed Underground Gas Pipeline shall be fully assessed prior taking up of work and the matter shall be taken up with the concerned service providers for redressal.
- 13. In case of improper restoration after laying of Underground Gas Pipeline, the Bank Guarantee shall be forfeited by NHAI.
- 14. NHAI has every right to cancel the permission given, without assigning any reason.
- 15. Applicant shall strictly adhere to the undertakings furnished along with the proposal. Any discrepancy would lead to violation of the Ministry's guidelines and the approval accorded shall stand cancelled.
- 16. In case of defaults/deviations found during inspection by Highway Administration, each deficiency shall be immediately rectified, which in no case should exceed 30 days from the date of inspection.
- 17. This license can be cancelled at any time by the Highway Administration for breach of any of the terms and conditions of license and the licensee/licensees shall not be entitled to any compensation for loss caused to him/them by Such cancellation nor shall be absolved from any liability already incurred by him/ them under this Agreement.
