In inviting a reference to the above-quoted communication, this is to inform you that the Compensatory Land, offered by you for raising afforestation, against the proposed diversion of forest land for your above project, can not be accepted for the purpose, since on field verification, it is found that all the plots are forest land having Sal forests of different ages. Divisional Forest Officer, Purulia's Letter No.610/28-48; dt.19/03/2015 (copy endorsed to you) may be referred in this regard.

Hence, you are requested to offer alternate suitable non-forest land of equivalent quantum as well as free from all encumbrances, so that afforestation works may be undertaken thereon.

You are, further, requested to furnish an undertaking to the effect that payment for enumeration cost of trees, over the proposed site, will be made from your end, as and when demanded.
