Subject: Report on FCA violation for diversion of 149.708 ha forest land for Widening and improvement of Yaingangpokpi-Nagaland Road Section of NH-202 into two laning with paved shoulder of 0.000km from Laikot to Hungpung of 48.273 km in the State of Manipur on EPC Mode by NHIDCL.

Sir,

In reference to the subject cited above, I am to state that the undersigned has enquired into the matter of violation of Forest Act by the NHIDCL for starting the expansion of Yaingangpokpi-Nagaland Road Section of NH-202 into two laning with paved shoulder of 0.000km from Laikot to Hungpung of 48.273 km in the State of Manipur on EPC Mode by NHIDCL before obtaining Stage-I approval. Required proceedings have been initiated against the offender in accordance with the provision under Section 41/42 of IFA, 1927 read with Rules Nos. 24, 26, 33 and 50 of Manipur Forest Rules, 1971.

An offence case vide No. 11 of 2020-21 was initiated against the contractor for violation of section 41/42 of IFA, 1927 read with Rules Nos. 24, 26, 33 and 50 of Manipur Forest Rules, 1971. As per the provision of MFR, 1971 the main charges framed against the contractors are breaking and removal of hill earth in violation of MFR, 1971. The details of assessment of damaged caused and required levies payable as per the provision of the Act/Rules are as follows:



The accused Varaha Infra Limited have been summoned and heard. They have agreed to pay due Government Charges for violation of Act/Rules and the same has been accepted. The accused has paid in full the due Government charges amounting to Rs. 119238/- (One lakh nineteen thousand two hundred and thirty eight only) vide TR5 No: 392591 dated 25/05/2021 Which was subsequently deposited to the exchequer vide challan number: 27 dated 04/06/2021


Hence, the offence case has been disposed off as per the provision of IFA, 1927 and MFR, 1971.

No:7/FCA/6/2018/YANG-UK-JESS: Whereas, in implementing the project "for diversion of 149.708 ha forest land for widening and improvement of Yaingangpokpi-Nagaland Road Section of NH-202 into two laning with paved shoulder of 0.000 km from Laikot to Hungpung of 48.273 km in the state of Manipur on EPC Mode by NHIDCL", the extraction and transportation of Forest Produces for the said project were carried out during the month of November, 2020 without any permit or consent from the authorised officer. In this connection an offence has been registered under Section 41/42 of Indian Forest Act, 1927 read with Rules No. 24, 26, 33 and 50 of Manipur Forest Rule 1971. The Range Officer, Ukhrul, Manipur has submitted a Forest Offence Report No.11 of 2010-21 dated 20th March, 2021.

2. The accused person had failed to obtain Forest Clearance and permission for extraction of Forest Produce from the competent authority and as such is in violation of Section 26 of IFA, 1927 and Rule No. 33 (a) of Manipur Forest Rule 1971. The offender is punishable with imprisonment for a term upto 6(six) months or fine which may extend to five hundred rupees or with both in addition to such compensation for damage to the forest. The Range Forest Officer, Ukhrul has accessed the value of the damage to the forest land at Rs. 1,19,238/-.

3. On explaining the provisions of the Acts & Rules, the accused pleaded guilty and requested to compound the offence. He also stated that such offence shall not be repeated in the future. After examining the Offence Report of the Range Officer, Ukhrul Range, statement of the accused and all relevant provisions the offence has been compounded and the accused person shall pay Rs. 1,19,238/- only as detailed below:

- i) Rs.59,619/- as against the value of the forest produce.
- ii) Rs. 59,619/- as against fine for the offence.

4. The above amount has been realized by TR5 No. 392591 dated 25/05/2021. Accordingly the case is disposed off.
