Compensatory Afforestation Scheme (as per plantation under the Forest Conservation Act, 1980) for the "for Development of Six lane access controlled in Delhi portion of Delhi Saharanpur Highway from Akshardham NH9 (Old NH24) junction to Delhi/UP Border (Ch. 0.000 to Ch. 14.750) in the state of Delhi on EPC mode under Economic Corridor in Phase 1 of Bharatmala Pariyojana, under FCA, 1980".

- 1. As per the existing ratio 10645 saplings can be planted in 9.58 ha. of land at the spacing of 3mX3m. Therefore, a Compensatory Afforestation of 10645 saplings has to be carried out over an area of 9.58 ha land located at NTPC Eco Park, Badarpur against the diversion of 9.58 ha of Deemed Forest land.
- 2. According to DPTA 1994 the cost of planting one sapling with seven years maintenance Rs. 5700/- has to be deposited per tree. As per FCA maintenance has to be done for 10 years therefore, per sapling cost / expenditure for 10 years is  $(5700/7 \times 10) = Rs. 8142.86/$ -

Therefore, the estimated cost for plantation of 10645 saplings over an area 9.58 ha. land in NTPC Eco Park, Badarpur as per existing norms of compensatory afforestation in Department of Forests and Wildlife GNCTD is 8143 X 10645 = Rs. 86682235/- (Rupees Eight Crore Sixty Six Lakh Eighty Two Thousand Two Hundred and Thirty Five only).

3. The components of plantation activity are as follows:

	creation of plantation.
11.	FYM Neem Cake, bone meal and insecticide for 7 years
12.	Casualty replacement in 2 <sup>nd</sup> year and 3 <sup>rd</sup> year for 20% of the plantation
13.	Watch and ward duty including monitoring and evaluation
14.	Total estimated cost of creation and maintenance including fencing

4. The said amount includes administrative & Contingency Charges @ Rs. 1000/- (Rs. One Thousand only) per sapling.\*
