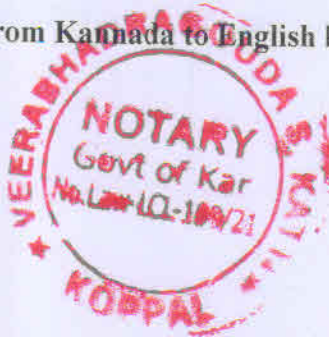

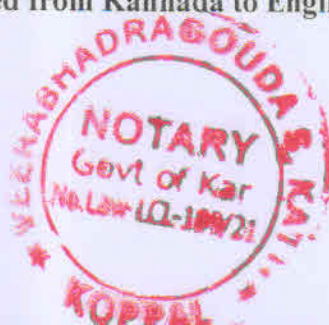

Mentioning the subject to issue of Form II, the rights under the schedule tribes and other traditional forest dwellers (Recognition of Forest Rights) Act, 2006.

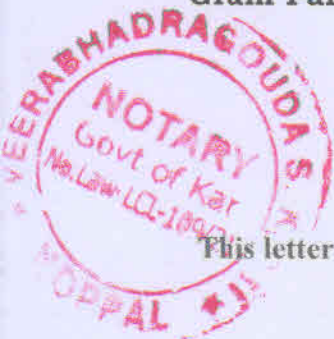
The Aaress Iron & Steel limited, Hospet plans to establish a water pipe line in the mentioned forest region, and the letter of instruction states that it must report to the Gram Sabha regarding the presence of persons from Scheduled Caste and other traditional forest dwellers groups in the Chikkasanakandi village Sy no 25 area of 1.84 hector. In accordance to the mentioned subject there were no such schedule tribes and other traditional forest dwellers are present in the Chikkasanakandi village Sy no 25 area of 1.84 (Hirekasankandi). It is reported that as there are no such schedule tribes and other schedule cast communities are living in the Chikkasanakandi village Sy no 25 area of 1.84. All the members of the village council who participated in the meeting unanimously agreed that there is no objection from the Scheduled Castes & Scheduled Tribes of our village (Chikkasanakandi) to build the water pipeline by Aaress Iron and Steel limited, Hospet in Chikkasanakandi village Sy no 25 area of 1.84 and the resolution was passed to the relevant superiors. All the members of the meeting again discussed at length and expressed their opinion on the basis of consensus to send the letter regarding the Aaress Iron & Steel Limited Hospet to construct a water pipe line for their company in forest land of Survey No. 25. The meeting proceedings letter will be sent to the relevant authority after everyone has had a chance to voice their opinions and has given their full agreement.
