With reference to the above subject you have asked for identification of 62.2ha of degraded forest area for plantation in lieu of the 31.079 ha forest land diverted under proposal No. regarding FP/KA/TRANS/115396/2020 in your division as per ref (1) & (2) .

So, The Range Forest Officer Gudibande has identified 62.2 ha of degraded forest land in Udagiri-Nallapanahalli village, Sy No. 37 of Narasimhadevarabetta V Block, 3rd Working Circle, Mandical Hobli, Chickballapura Taluk & Chinchinahalli village Sy No. 17 of Narasimhadevarabetta V Block, 3rd Working Circle, D Palya Hobli, Gowribidanur Taluk. The RFO has sent Form-C (Land Suitability Certificate), Topo Map, Geo reference map & KML file in ref (4).

The rates for Compensatory afforestation have been revised as per ref (5). These rates have been used for preparing CA scheme and calculation of the amount to be paid by the user agency. Details are as follows.
