Fatehgarh Sahib under Forest Division Patiala. The above application endorsed to Forest Range Officer, Sirhind for site inspection along with map of the site. Forest Range Officer, Sirhind has reported to this office that 0.0076 hac. forest area will be affected by this diversion and the user agency has violated the act by using 21 Sqmtr Kachha Passage on GT Road Km 248-249 R/s prior approval of G.O.I Forest Range Officer, Sirhind has issued a damage report No. 79224 dated 13.03.2019 against the user agency under Indian Forest Act 1927 and the user agency has deposited the penalty . The approach road which was being used by the user agency has since been closed.
