

## Technical Details ( Model-3)

Technical details of Compensatory Afforestation are as follows:

- (a) General Details :- 1111 plants/ha. will be planted after deep ploughing.
- (b) Spacement :- 3mt X 3mt / for Tree species and alternate one row of grass in between the lines.
- (c) Spacies :- Kanji, Kadaya, Neem, Gunda, Gundi, Ardusa & Garmalo, etc.in tree Spp.
- (d) Nursery Technique:-Nursery will be raised in polybags of 15cm x 25cm.x 200mg. of size.
- (e) Site Preparation:- Deep ploughing and furrow at 3mts. interval.
- (f) Plantation Method Size of Pit,.Ploughing etc.:-1111 per Ha. Aliigment and digging of pits 0.45x0.45x0.45
- (g) SMC Works:-Chack wall/retaining wall/Check dem as per site requirement.
- (h) Protection:- Barbed wire fencing, arround the boundary.
- (i) Silvicultural Operatations:- Three soil working in current year followed by two soil working in second year and one soil working in Third year with support waterings.
- (j) Maintenance :- By casual labour for 9 years.
- (k) Subsequent :- Silvicultural Operatation proposed such as cleaning, cutbacks, thinning etc. (As per Species specific requirement) Whenever required.
- (I) Arrangement for people participation (if any) for long term sustenance of the plantations-Departmental staff.
- (m) Proposed monitoring mechanism.:- Monitoring will be done by monitoring wing of forest Department.
