With reference to the above subject, the M/s Udupi Kasargode Transmission Limited New Delhi has submitted the proposal for diversion of 8.968ha. forest land coming under 400 KV Quad D/C Transmission Line project as per Forest Conservation Act 1980 in Central Government web portal proposal No. FP/KA/TRANS/115396/2020 and also submitted hard copies of the online proposal in 7 copies to this office vide reference (1).

Accordingly, the forest lands coming under the proposal were inspected by Range Forest office Moodabidfre Range and Assistant Conservator of Forests, Moodabidre sub division, Moodabidfre and submitted the concerned forest maps, tree enumeration list vide reference letter No. (2) and (3). As per the proposal submitted under 400 KV Quad D/C Transmission Line constructing under Moodabidre Range in Reserve Forest area 265 trees and under deemed forest area 565 trees having Total 830 trees are marked.

Regarding identification of area for compensatory afforestation, Deputy Conservator of Forests, Chikkaballapur has identified and proposed 62.2 ha. Degraded forest area in Sy. No. 17 (Chinchenahalli Village) and Sy. No. 37 (Udagirinallapanahalli Village) in Gudibande Range, Chikkaballapur District, Further, Chikkaballapur has also issued the CA land suitability certificate and CA scheme. The hard copies of CA related information (Topo Sheet, Topo map, Geo referenced map, CA land Suitability certificate & CA Scheme)

Proposal is now submitted in 06 copies along with trees enumeration lists pertaining to the proposal for diversion of 8.968ha. forest land as per forest conservation act 1980, submitted by the M/s Udupi Kasargode Transmission Limited New Delhi, for the construction of 400 KV Quad D/C Transmission Line for further necessary action
