In complinace of the Ministry of Environment and Forests (MOEF), Government of India's letter No 11-9/98-FC(pt) dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5<sup>th</sup> February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that **7.152 hectares** of forest land proposed to be diverted in favour of construction division public works department...chinyalisour uttarkashi for road construction in uttarkashi district falls within jurisdiction of Bangoan-Chapra-Kaslana.village (s) in chinyalisour and Barkot tehsils.

It is further certified that:

- (a) the complete process for identification and settlement of rights under the FRA has been carried out for the entire **7.152 hectares** of forest area proposed for diversion. A copy of records of all consultation and meetings of the Forest Rights committee(s), Gram Sabha(s) sub- Division laevel Committee(s) and the District Level Committee are enclosed as annexure 23 to 23.2 annexure
- (b) the diversion of forest land for facilities managed by the Gvoernment as required under section 3 (2) of the FRA have been completed and the Grama Sabhas have given their consent to it;
- (c) the proposal does not involve recognised rights of Primitive Tribal Groups and Pre-agricultural communities.
