### **PROJECT BRIEF**

The role played by Transportation in Overall Development of the Country is very highly significant. To improve the economic and social welfare of the people, it is common to take up development of Highway projects. The Ministry of Road Transport and Highway, Govt. of India has proposed to take up the development of various National Highway Corridors under NHDP Phase - IV / Bharata Mala programmes in the country. The NHDP programme is applicable to those corridors where the intensity of traffic has increased significantly and there is requirment of augmentation of capacity of safe and efficient movement of traffic.

The Project Highway proposed for 4/6 laning / up- gradation is a National Highway No.66 (earlier NH-17), it starts from Goa-Karnataka Border at existing KM. 93.700 and ends at Kundapur at existing KM.283.300 in Karnataka State. The entire project stretch runs in karnatka State. the existing ROW is varying from 19 to 45m from KM 93.700 to KM 283.300. The said Project Highway does not pass through any National Wild life / Scanctuary. No Tribal Dwellers are residing along the stretch of Highway.

III dated 19.02.2014 (copy enclosed).

# 1.4 FOREST CLEARANCE :-

The Ministry of Environment and Forests ( MoEF), New Delhi, has granted in-principal approval for diversion of 159.80 Ha. ( including 6.68 ja. Of area for re-diversion which falls in Sea Bird Naval Base Project Area ) for the forest land in favour of project Director, national Highways Authority of India, project Implementation Unit, mangalore in Karwar - Honnavar - Kundapur Division for 4/6 laning of Goa - Karnataka Border to Kundapur section of NH - 66 ( earlier NH- 17 ) (Km 93.700 to km 283.300 ) vide letter F.No.08-78/2013-FC dated 06.05.2014.
