Sub:- Lease of land - an area of one acre out of P.S.NO. 108A1 of Kodibag Karwar Taluk request of the Coronet Canning Co., Malpe.

Letter No. B3.R.DIS-1784/60 dated 18-4-1962 from the Chief Conservator of Forests in Mysore, Bangalore.

ORDER:-

The Chief Conservator of Forests has reported that the Coronet Canning Co., Malpe has applied for grant of 2 acres of land in P.S. NO. 108A1 of Kodibag Village, Karwar Taluk for installation of a Fish Canning Factory at Karwar. He has also reported that the Coastal track of Kanara District is backward with regard to Industries, that fishing is an important industry of the district and that granting of land to this industry gives scope for increasing activity in Karwar Town. In the circumstances, the Chief Conservator of Forests has recommended for the grant of one acre of land in P.S.NO. 108A1 of Kodibag village in Karwar Taluk for a period of five years in the first instance subject to the terms and conditions as are in vogue with an annual rent of Rs.240/= per acre per annum. He has solicited orders of Government in the matter.

After due consideration of the request of the Company, Government are pleased to order the release of an area of one acre in P.S.NO. 108A1 of Kodibag village, Karwar Taluk, North Kanara District on lease basis for a period of five years in the first instance subject to the usual terms and conditions as will be prescribed by the Chief Conservator of Forests with an annual rent of Rs.240/= per acre per annum, in favour of the Coronet Canning Company, Malpe.

The Chief Conservator of Forests is directed to take further action in the matter.
