

1. This certificate shall remain valid for a period of five years from the date of its issue.
2. It may be renewed on submission of fresh application along with prescribed fee provided that the application has been submitted three months before expiry date of previous registration.
3. The certificate shall be operative in the state of Punjab only, except in area declared by as Controlled Area under the Punjab New Capital (Periphery) control Act. 1952.
4. It will not be used for the purpose other than the purpose of conducting business as a promoter as specified under the Punjab Apartment and Property Regulation Act, 1995 and the rules made there under.
5. The competent Authority has the right to withdraw or cancel the certificate at any time during the tenure of registration, if it is found that:-
 - a) The Promoter has given any wrong information in his application for registration;
 - b) The Promoter has been adjudicated as insolvent or is undercharged insolvent; or
 - c) The Promoter has been convicted under the Act or any other law related the construction or use of premises.
 - d) The Promoter has contravened any of the terms and conditions of the certificate or any of the provisions of the Act or the rules made there under.
