The Optical fibre cables are always laid along the road side due to easy supervision, quick and low cost of maintenance. The Applicant does not have to acquire land for this purpose as the road side land either belongs to PWD /or any other Government agency/agencies of Haryana State. Laying of Cable would be done with 0.45 meter width of surface land, & up to 1.65 metres of depth and near to the extreme road boundary where alignment of trench will be done in such way that no tree will be required to be cut.
