## Detailed Note on Project

M/s. Sri Balaji Industrial Engineering Ltd is having existing Sponge Iron Plant for production of 0.12 MTPA sponge iron at Barajamda village of Singhbhum West Dist of Jharkhand. The plant site is located at Basti Road, PO.-Barajamda, Dist. West Singhbhum, Jharkhand Barajamda , district West Singhbhum , State Jharkhand . The area around the Plant is in general a hilly terrain , whereas the plant is located in a plain area.

The existing unit of 120000 TPA (4x100 TPD) sponge iron was established after obtaining consent to establish (NOC) vide letter N-173, dated 09.03.2005 from Jharkhand State Pollution control Board (JSPCB). Also Consent to Establish (NOC) vide letter JA/2655/W/3179, dated 27.09.2006 from JSPB for M.S. Ingot – 86400 MT/yr was obtained.

In order to fulfil the requirements of Acts and addition of iron ore washing plant and M.S. Ingot project report has been prepared as modification and diversification documents for Environment Clearance from the concerned authorities.

Steel consumption is expected to grow at an average rate 6.8 per cent to reach 104 MT by 2017 and steel production in India expected to go up to 200 MTPA by 2020 from current 70 MTPA driven by rising infrastructure development and growing demand for automobiles. Selection of a suitable production process and the capacity of production units from the nucleus around which the basic concept of a plant is developed. Thus the units envisage to utilize the opportunity by controlling the cost and environment by backward integration along with the existing units. The plant site is located on contiguous land in Village Barajamda under Noamundi Circle District West Singhbhum of Jharkhand state. The nearest town to the site is Barbil in Odisha, which is at about 12 km away on its North East direction. This existing sponge plant will cater the demand of sponge for the region as well as for other parts of the country.

Existing Sponge Plant of Sri Balaji Industrial Engineering Ltd covers an area of 6.73 Ha which includes applied Forest area for diversion of 1.66 Ha. This applied area is located in village Barajamda in Chaibasa Forest Division under West Singhbhum District of Jharkhand State.

The limiting boundary of the existing steel plant is bounded by Latitude: **21°10' 7" N** to **21°10' 11" N** & Longitude: **86°26' 8" E** to **86°26' 23" E** of survey of India Topo Sheet No 73 F/8 (Plate No. -I).

The Sponge plant area is covered by the Survey of India Toposheet No. 73 F/8 on RF 1:50,000 (Plate-I). The Plant site is approached from Barajamda at Khasjamda for a distance of 1 Km towards Noamundi Village on Plant approach Road. Most of the areas have shown on plain topography. Altitude of the Plant area varies from 440 m to 443 m above mean sea level in general. The color of top soil is white to yellowish in most of the portion except at those places which are mineralized; displaying red color.

**Accessibility:**

The Plant site is approached from Barajamda at Khasjamda for a distance of 1 Km towards Noamundi Village on Plant approach Road. The nearest Railway Station is Barajamda which is about at a distance of 2 km from the Plant area. The nearest Airport is Birsa Munda Airport at Ranchi which is about 225 Km away from the Plant area. The Plant area is away from the district headquarter towards North East direction with 90 km aerial distance. The area around the project is covered with thin bush cover. Due to age old history of Iron ore mining and allied industrial activities in this region, road and rail network is well developed in this area. Railways are completely electrified and broad gauged. Facilities of loading of wagon are also available. The Gua-TATA Nagar branch of Eastern Railway connects the plant area at Barajamda. Thus, it is well connected with important Industrial as well as mining areas of Jharkhand and neighboring State.

**Details of adjoining area & drainage**

The study area consists of Karo river and State Hingh Highway is in Southern part. The eastern and western part of the study area represent rural environment with sparsely located villages. The average annual rainfall of the study area is about 1275 mm. There is no irrigation facility available in the study area. Groundwater is the principal resource for domestic and irrigation purpose in almost all villages in the study area. River bed is stony. Granite & Dolorite stone is present in the river bed. Though. Major water channels form dendritic pattern, some annular pattern can also be seen which follow the slope of the hill on all sides. They carry huge amount of water during rainy season which can also be preserved to fulfill the requirement of water for all purposes.

**Meteorology**

The climate of the study area is sub humid sub tropical; the average annual rainfall in this region is 1275 mm. The mean annual temperature varies from 29.0° C to 44.7° C however the mean summer temperature ranging between 29.0° C to 32.4° C and mean winter temperature between 17.7° C to 19.0° C. The soil temperature regime is hypothermic and soil moisture regime is 'Ustic'. The study area may be characterized under three natural formations namely Central plateau, Lower plateau and Damodar valley. The agro ecological sub region is hot dry and sub humid plateau. The seismicity Index of the area is 3.

**Life of the Steel Plant:**

The total life of the Steel Plant shall be 99 years.

### Justification

After signing the MOU with the government of Jharkhand, Company was assured for the assistance and relief from the Government of Jharkhand for availability of principal raw material like Iron-ore, coal etc along with acquisition of land, allocation of water and sanction of power.

Company was purchased land for the establishment of Sponge Iron unit. In course of acquisition of land, 19 acres of GM land was applied for 30 years to Govt of Jharkhand. After scrutiny of the said land records by the Revenue Department, GoJ, we were directed to deposit 80% for the total land value of 6.48 acre . (Xerox copy of letter attached as Annexure 1A).

As per instruction given in the letter of revenue department, DC Chaibasa for the area the Salami amount Rs.- 37,26,163/- ( Rupees Thirty seven Lakhs twenty six thousand and one hundred sixty three only ) has been fixed. 80% of this amount has been deposited as per instruction for lease of 6.84 acre GM land.

The amount was deposited into two parts. After receiving the amount by the revenue department, DC Chaibasa has issued a letter for the execution of lease agreement for the area 2.48 acre while their demand was for total 6.48 acre which was deposited by the company for the area 6.48. In course of given lease settlement to the company by DC Chaibasa, it was found that out of 6.48 acre land, 4 acre land for the same plot number was recorded as Jungle-Jhari land in the khatian.

In pursuance of this process DC Chaibasa was written a letter to the Divisional Forest Officer, south circle Chaibasa for NOC for the same land. ( Xerox copy of letter attached as Annexure 1B).

Further Divisional Forest Officer (DFO) Chaibasa south given a letter to DC Chaibasa and requested to issue NOC regarding the same land as the owner ship of the land is revenue department of Government of Jharkhand after the application submitted by the company for the use of 4 acre Jungle-Jhari land. (Xerox copy of letter attached as Annexure 1C).

In this regards DC Chaibasa was issued NOC to the DFO south circle Chaibasa for further process accordingly. ( Xerox copy of letter attached as Annexure 1D).

Company was submitted the forest clearance application in 10 sets of hard copies during Year 2008. Company was also submitted the detail of CA land (4 acre) along with the application along with NOC of Jungle Jhari Land from Deputy Commissioner Chaibasa. DFO, south circle, Chaibasa was raised on the submitted Forest Clearance proposal vide letter No. 681 dated 05.03.2008. ( Xerox copy of letter attached as Annexure 1E).

Now, again we uploaded the same proposal online in PARIVESH portal for obtaining forest clearance of Jungle Jhari Land of 4 acres.


