The point wise reply is also given as below:

1. The DGPS authenticated map of identified degraded forest CA land to an extent of 5.48 ha is not uploaded in the web portal. The authenticated map should contain the signatures of forest range officer, GIS cell, O/o PCCF AP.

4. The user agency uploaded the undertaking on submission of RoFR certificate, but the RoFR certificate under RoFR Act, 2006 to be issued by District Collector, SPSR Nellore which is mandatory has not uploaded in PARIVESH.

Now BPCL has submitted revised application to District Collector – Nellore for issuance of RoFR certificate vide letter BPCL.KHPL.MoEF.AP.DM.01 Dt.29.03.2023. further due to regional administrative changes/new collector yet to take charge and subsequent action to be taken.

We further request you to consider the undertaking for RoFR certificate which is being obtained from district collector Nellore. BPCL shall submit the RoFR certificate during stage 2 Approval.





Dear Sir,

Bharat Petroleum Corporation Limited, a Govt. of India Enterprise under the aegis of Ministry of Petroleum & Natural Gas, are the second largest company in the country effecting the supplies of essential commodities like MS, HSD and SKO etc. to civilian as well as various Government Agencies. We propose to lay a 423 KMS long cross-country multiproduct pipeline from our under construction Coastal import terminal at Krishnapatnam Port at Nellore in Andhra Pradesh state to our proposed terminal near Malkapur Village, Y.Bhongiri District in Telangana State. The said pipeline is being laid for transportation of finished petroleum products from our refineries at Mumbai and Kochi. The proposed pipeline shall pass through the districts of Nellore, Prakasam and Palnadu of Andhra Pradesh. The approximate length of pipeline in Andhra Pradesh state is 308 KMs.

We wish to inform that Petroleum and Natural Gas Regulatory Board (PNGRB), a regulatory board under MoPNG, has issued Letter of intent authorizing us to execute the project vide letter no.: PNGRB/Auth/3-PPPL (10)/2019 dated 17-Feb-2020.

The proposed 16inch Dia underground multi-product petroleum pipeline along with 40mm dia HDPE ducts for Optical Fibre Cable (OFC) will pass through SPSR Nellore District of Andhra Pradesh. The proposed pipeline alignment is passing through Nellore forest Division in SPSR Nellore District. The details of area required for diversion of forest land for laying this pipeline Division wise is furnished below:
