Also private land is very less around the proposed site and the patch of forest land identified for the said project is most suitable.

Further, explored alternatives showing details of tree enumeration, area etc. may be provide and all alternatives explored are required to be marked on the KML file.	During the project preparation and finalization of FCA Case Three sites were examined. In which proposed site was examined. In which proposed site was suitable as falling of trees i,e, 142 nos (5 nos Deodar, 59 nos Kail, 78 nos Populus deltiudes) were involved. After examining other alternative they were not found feasible as it was involving more forest land. 1st alternative was involving 1-87-91 hectare, forest land, and nos of trees i,e,154 nos (73nos kail and 81nos deodar) and 2nd alternative they were involving 1-90-91 hectare forest land more trees i,e, 180nos (50 nos Kail and 130nos Deodar). It is certified that population of 29000 of 15 Panchayats under the jurisdiction of Tehsil Anni will be benefited directly & indirectly Hence the proposed alignment has been found most suitable and acceptable to all.
