Kwar HE Project, 540 MW, Run of river scheme on river Chenab is to be constructed in the Tehsil, Nagseni, of District Kishtwar. Construction activities of the project are likely to be started in second quarter of 2021.



In respect of the subject cited above, it is submitted that a Gram Sabha under Forest Right Act 2006, was conducted on 12-02-2021 in respect of diversion of forest land for construction of road up to TRT outlet for Kwar project in village Bhagana. It is pertinent to mention here that Forest Right Committee for all Panchayats of Block Nagseni, including Bhagana-B and Bhagana-C has been constituted. The members of Forest Right Committee of Bhagna village were present in the meeting. In the meeting, the members present were intimated that the purpose of the meeting is to record the objections as per the Forest Right Act 2006. The land is purely forest land and not having any type of habitation/structure. The proposed area does not involve recognized rights of Primitive Tribal Groups and Pre-Agricultural Communities. Upon discussion, the members present intimated that they have no objection with regards to diversion of Forest Land/State Land for the road alignment towards of Kwar Project.
