I wish to inform you that, with reference No. 8th the proposal the area required for diversion is 0.312 ha i.e. 0.27 ha in Panai RF located in Cauvery North Wild Life Sanctuary and 0.047 ha in Noganur RF. In this proposal, there is a difference between the proposed area and the uploaded .kml file. The wildlife warden requested that a clear map be provided showing the extent of the area that falls within Cauvery North Wildlife Sanctuary and its Eco-sensitive zone.
