As you are aware Gujarat Gas Limited (GGL) is India's largest City Gas Distribution (CGD) Company, subsidiary of Gujarat State Petroleum Corporation, promoted by **Government of Gujarat**, has received authorization from **PNGRB (Petroleum and Natural Gas Regulatory Board)**, for laying, building, operating and expending City Gas Distribution Network in Thane GA (except the area already authorized) consisting palghar & thane district in Maharashtra state.

Gujarat Gas Limited has planned to set up CGD network in the entire Thane Geographical area (consisting Palghar and Thane District) to provide natural gas to every end user for domestic, commercial and industrial use in phase manner.
