- (i) **Short** narrative of the proposal and project/scheme for which the forest land is required.

With the high demand of public and the local panchayat for the construction of new road to their village the survey work was conducted from kabirthang to Ratomatey School by the Consultancy, and the detail project report was submitted to the ministry government of India for the sanction of the Said Road. So the work was sanctioned under PMGSY scheme during the year 2016-17 under Rural Management and Development Department, With amounting to Rs 849.12 lakh, the length of the road is 10.325KM, width 6mtr, the said road will connect the village Kabirthang, Danteybari, Ratomatey School, Rai Gaon and Khitawara gaon of Omlok ward, while construction of the road the alignment of the road is passing partially through the Khasmal/Gaucharan of Yangtey and Omlok. Therefore the onluy suitable and technically feasible alignment was to pass to the forest land( hasmal) covering 0.2987 HA only, which is unavoidable to construct the road under any circumstances and clearance for the forest area involved is asked for.

The take off point of the road is from kabirthang and then the alignment of the road is passing through Danteybari village and then the Ratomatey school and then other villages, so in between Danteybari and Ratomatey school there is Khasmal of forest naming yangtey and omlok khasmal, it is noted that without passing through these khasmal it not possible to construct the road, as there is no alternatè take off point of the road to connect the Danteybari village and the

Ratomatey school, further the alignment of the road cannot change due to the high stiffness of the area and more than 100 people will be unconnected by Said road if the alignment is changed.
