PROVISIONAL NO OBJECTION CERTIFICATE

It is provisionally certified that the Department of Fisheries, Government of Arunachal Pradesh has no objection for implementation of Dengzi Hydro Electric Power Project (18 MW) on Nargum river in West Kameng district, Arunachal Pradesh by M/s Buru Enterprises, Yara-Tabang Complex,ESS sector, Itanagar, subject to following terms and conditions:-

- 1. This is purely a provisional NOC, enabling to undertake Environment Impact Assessment (EIA) study only. The Firm/Developer shall have to obtain final NOC from the Department and is subject to review of receipt of Expert recommendation /comments.
- 2. There should be a detailed study on the impact of such construction on the aquatic ecology and on the habits &habitats (Upstream/ Downstream) of the incumbent indigenous fish species.
- On completion of Environment Impact Assessment (EIA) study, the Firm/Developer must submit a copy of the Environment Impact Assessment Report related to aquatic ecology and fish bio-diversity along with Environment Management Plan (EMP) to this office for records and future reference for issue of final No Objection Certificate (NOC).
- 4. Expenses of Expert/Consultant engaged for cross verification/authentication of the impact as detailed in the EIA Report on incumbent indigenous fish species before issuing final NOC may be included in the project cost and have to be borne by the Firm/Developer.
- 5. Adequate funds should also be earmarked for trapping and transportation of different fish species coupled with sufficient fund provisions for construction of Hatcheries, nursery, rearing and stocking ponds for breeding of indigenous fish species (like Mahseer, schizothorax, Cat fishes, Indian Major Carps (Rohu, Mrigal, Catla, spp.) & Exotic carps (Grass carp, Silver carp, Common carp) and Ornamental fish species etc at suitable location for stock replenishment, wherever necessary.
- 6. A suitable joint mechanism for monitoring must be evolved/devised for overseeing effective implementation of all the provision/clause.
- 7. Management of water bodies should be handed over to the Department of Fisheries, Govt of Arunachal Pradesh for development/management of reservoir fisheries.
- 8. A copy of the Final Environmental Clearance from the Ministry of Environment & Forest (MOEF) should invariably be submitted to this office for obtaining Final Clearance and for our office record. All conditions therein should strictly be adhered to.
