In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC (pt.). Dt. 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 on (FRA for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that 60.0309 Hectares of forest land proposed for formation of R&B (03) line Roads from 1.RKothagudem to Kurnapalli (12.195), 2. Seethanagaram to Kurnapalli (27.2269), 3.Tippapuram to Chennapuram (20.609) in Bhadrabri District falls within the jurisdiction of Dummugudem/Charla Forest Ranges & Tahsil.

It is further certified that:

- The complete process for identification and settlement of rights under the FRA has been carried out for the entire 60.0309 Hectares of forest land proposed for formation of R&B (03) line roads. A copy of the resolution of RoFR Committee Grama Sabha of R.Kothagudem / Tippapuram / Kurnapalli Villages of Charla Mandal and Mulakanapalli village of Dummugudem Mandal.
- The proposal for such diversion (with full details of the Project and its implications in vernacular/local Language) have been placed before Grama Sabha of Forest Dwellers, who are eligible under the FRA.
- The Grama Sabha has certified that all Formalities/Processes under the FRA have been carried out, and they have given their consent to the proposed diversion, if any, having understood the purpose and details of proposed diversion.
- The discussion and decisions on the above said proposals had taken place only when there was a quorum of Minimum 50% of the members of the Grama Sabha present.
- The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Grama Sabhas have given their consent to it.
- The rights of Primitive tribal groups and Pre-Agriculture Communities, Where applicable have been specifically safeguard as per section 3 (1) (e) of the FRA.
