Accordingly the Gram Panchayats have been convened the meeting of Gram Sabha under the Chairman ship of Sarpanch's, along with Secretary and unanimously passed resolution stating

that there is no objection for diversion of proposed forest land in favour of Executive Engineer(R&B), Special Division, Kothagudem as there is no encroachments by the tribal people in the proposed forest land to be diverted and further resolved that there are no pending RoFR claims to be settled under the forest Rights Act.

Basing on the resolution passed by the Sub Divisional Level Committee, Bhadrachalam the members of District Level Committee, Bhadradi Kothagudem have passed resolution that there is no objection regarding the diversion of forest land measuring an extent of 60.0309 Hectares for formation of (R&B) roads which leads from (1)R.Kothagudem to Kurnapalli (12.195HA), (2) Seethanagaram to Kurnapalli (27.2269HA) (3)Tippapuram to Chennapuram (20.609HA) and which roads are covered under Forest lands of Cherla and Dummugudem Forest Ranges in Bhadradi Kothagudem District in favour of Executive Engineer(R&B), Special Division, Kothagudem subsequently the members given their consent to issue RoFR clearance certificate in Form-1.
