Sir,

I am to refer to your letter, quoted at Sl.No.1 & 2 above
seeking prior approval of Central Government in accordance with
Section 2 of Forest (Conservation) Act, 1980.

After careful consideration of the proposal of the State
Government, the Central Government hereby conveys its approval
under Section 2 of Forest (Conservation) Act, 1980 for diversion
of 4.93 ha. of forest land for the purpose of Karikkayam Hydro-
electric Project in Vadasserikkara and Ranni Range, Ranni Division,
Pathanamthitta District subject to the following conditions:

1. Legal status of forest land shall remain unchanged.
2. The lease is for a period of ten years.
3. Compensatory afforestation shall be raised over equivalent
non-forest land at the cost of the user agency. The non-
forest land identified for this purpose shall be handed over
to the Forest Department and notified as Protected Forests
before release of forest land.

4. The total forest land utilised for the above said purpose shall not exceed 4.93 ha.
5. The proposal for renewal of lease shall be submitted six months before expiry of the lease.
6. Any other condition stipulated by the State Government.
