उपरोक्त विषयक सन्दर्भित पत्र के क्रम में विषयक कार्य में लगायी गयी आपत्तियों का विन्दुवार निराकरण निम्नानुसार है-

1	As per DSS analysis of new CA area, 17 ha is found to be VDF and 16 ha is found to be MDF. The DFO is required to submit a site inspection report of the MDF area clearly mentioning if the MDF area is suitable for plantation. The area falling in VDF shall be revised and details be submitted on the online portal.	As per CA land provided by your office the digital map, topo sheet and KML file is attached for further necessary action.
2	Details of the 56.819 ha of non-forest land are uploaded in the field additional document in Part 1. Same shall be filled in para B of part 1 by the User Agency.	PARIVESH portal does not allow user agency to edit this detail. Hence same may be modified from DFO office.
3	Details of 76 saplings are required to be uploaded at para 4 in part II by the Forest Department.	Reply may be submitted by DFO office.
4	The DFO along with the User Agency shall visit the proposed muck dumping sites and shall review and minimize the area proposed for muck dumping. It shall be ensured that revenue lands/ degraded forests with gentle slope are selected.	As per directions the dumping site has been reviewed and muck dump area minimized to 7.329 Ha.
5	DFO shall submit the reclamation plan for the muck disposal area.	Reply may be submitted by DFO office.
