MUCK MANAGEMENT PLAN

प्रमाणित किया जाता है कि जनपद आगरा तहसील बाह में आगरा-बाह-कचौरा घाट मार्ग के किमी चैनेज 44.700 से 91.200 तक मार्ग की दाई पटरी पर ग्राम अरनोटा से ग्राम कचौरा घाट तक भारत संचार निगम लिमिटेड द्वारा ग्राम पंचायतों को भारतनेट योजना के अंतर्गत संयोजन हेतु ऑप्टिकल फाइबर केबल डालने हेतु 1.3 95 हेक्टेयर संरक्षित वनभूमि प्रभावित होगी। उक्त संरक्षित वनभूमि में खुदान कार्य के पश्चात उत्त्पन्न अवयवों /कूड़ा-करकट हेतु मक डिस्पोजल प्लान का विवरण निम्न प्रकार है-

Disposal management plan

While preparing FCA case, if there is any activity in the project which involves digging of land, muck disposal/management plan has to be prepared.

Should include

1. Calculation of Mark to be generated, self factor has to be applied. N.A.
2. Quantity of Mark to be utilized in the project activities. N.A.
3. Balance quantity of muck, which requires disposal/management plan? N.A.
4. Carriage of muck from the muck generation site in the dumping site. N.A.
5. Ownership of land and the consent of land owner in case muck disposal on non forest land. N.A.
6. Photograph and carrying capacity of proposed dumping site(muck disposal site) N.A.
7. Development of dumping site construction of retaining walls and other structure as per requirement of the site. The objective is to completely stop rolling down of the muck. N.A.
8. Rehabilitation of dumping site like leveling, planting of grass, shrubs and tree species.

After OFC cable work will be done

cost to be incurd on the above activities has to be given component wise. Details of dumping site including length, width and height of structures to be exacted must be mentioned.

undertaking by the user agency has to be given to the effect that

1. Muck management plan will be implemented by the user Agencies and case of non implementation of the plan, they will be liable to penalty action at their cost.
2. the proposed dumping site is located away from river /stream/ Nala.

certificate for no mark will be generated and disposed at site
