NOTIFICATION

S.D. Patna 15, Dated -8-1997.
Whereas, the land on both the sides of
Roads having only tree or not have been notified as protected
forest under section 29 of the Indian Forest Act 1927 vide
Government notification no. 921-E. Dated. 28-8-97
Now, therefore, in exercise of the powers conferred
by the section 30 of the Indian forest Act, 1927 read with
clause (a) of sub section (1) of section-80 of the said Act,
the Governor of Bihar is pleased to.

- (a) declare all the trees in the above protected
forest to be reserved from the date of this
notification.
- (b) Prohibit the quarrying of stone, or the burning
of lime or or charcoal, or the collection of
subject to and any manufacturing process, or removal
of, any forest produce and the breaking
up of land or clearing for cultivation of
building, for herding cattle from the date
of this notification/provided the above rest
restrictions will not apply in the case of any
bonafide operations of the parent department
concerning the broadening of road, plugging/
repair of breaches in road, and other
similar bonafide activities for which the
concerned parent department shall specify the
the competent officer for ordering such operation
which will be duly notified to the concerned
Divisional Forest Officer.
- (c) Entrust the responsibility of the above
mentioned protected forests for the purpose of
afforestation on the available land, departmental
felling of matured timber and other related
activities for the proper maintenance and up keep
of the aforesaid protected forest to the
forest Department

NOTIFICATION

Patna 15, Dated: 8.1997.

Whereas, the Governor of Bihar is of the opinion that the making of enquiry and record, contemplated under sub-section (3) of the section 29 of the Indian Forest Act., 1927 (Act No. XVI of 1927) will occupy such length of time as in the meantime it may endanger the rights of the State Government.

Now, therefore, in exercise of the powers conferred by the proviso of the aforesaid sub section and by sub section (1) of section 29 of the said Act, the Governor of Bihar is pleased to declare that pending such enquiry and record, the provisions of chapter IV of the said Act be not applicable to the lands on the roadsides whether there is any tree or not, specified in the schedule I, II, III, & IV hereto without abridging or affecting existing rights or the bonafide operations of the parent departments such as repairs, broadening of road, etc.
